I refer to your email of 11 January 2024 requesting information in relation to for Elective Recovery and Planned Care.

I can confirm on behalf of NHS Lincolnshire Integrated Care Board (ICB) and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold the information that you have requested. Please see further details below:

I am writing to request information regarding the capital deployment to system partners for elective recovery and details of the ICB Senior Responsible Officer (SRO) for Elective Recovery and Planned Care.

1. Capital Deployment for Elective Recovery:

- **Could you please provide details on the amount of capital deployed to system partners to assist in elective recovery from January 2023 – December 2023. Kindly break down the amount by partner or area if possible.**

Upon review of all capital schemes within the ICS during the time period concerned, no investment made has been with the specific intention of elective recovery. However, investment has been made in numerous areas where this will enable increased activity levels supporting elective recovery.
