I can confirm on behalf of NHS Lincolnshire Integrated Care Board (ICB) and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not hold the information that you have requested. Please see further details below:

- 8. What is the organisation's annual energy spend for the following:**
 - a. Electricity**
 - b. Gas**

- c. **Water**
9. **What is the total number of meter points for Electricity for:**
- a. **Non Half Hourly (NHH) meter points**
 - b. **Half Hourly (HH) meter points**
10. **What is the total number of Gas meter points?**
11. **What is the total number of Water meter points?**
12. **What is the total number of meter points for specialist gases and liquids?**
13. **Can you please provide me with the contact details of the key person responsible for this contract or around energy management.**

This information is not held by the ICB. The ICB's headquarters building is leased from [NHS Property Services](#). You may wish to contact them directly for the information you require.
