FREEDOM OF INFORMATION – DECISION NOTICE

Dear Requester

FOI Reference Number: 72390

I refer to your email of 29 January 2024 and your clarification email of 29 January 2024 requesting information in relation to winter resilience payments.

I can confirm on behalf of NHS Lincolnshire Integrated Care Board (ICB) and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do/do not hold the information that you have requested. Please see further details below:

I would like to request the following data for Lincolnshire ICB:

[Clarification – Yes please could you confirm actual spend to the end December 2023. If there is any further expenditure planned, or committed costs, for the remainder of the financial year please could this also be listed.]

- 1. From the total winter resilience payments from NHS England to your ICB in the financial year 2023/24, what spend was committed to primary medical services (PCNs and/or GP surgeries)?**

I can confirm that the ICB do not receive any funding from NHS England which is specifically named “winter resilience”.

However, we do have a winter support allocation of £200k only, or a winter funding budget of which £325,737 has been spent by 31/12/23 by primary medical services.

- 2. From within the ICB’s total budget in financial year 2023/24, what is the total committed spend on primary medical services (PCNs and/or GP surgeries) which is not delegated and wholly discretionary?**

The total value is £15.9m from 01 April 2023 – 31 December 2023.
