I refer to your email of 01 March 2024 requesting information in relation to whether the ICB has a contractual agreement in place with S12 solutions.

I can confirm on behalf of NHS Lincolnshire Integrated Care Board (ICB) and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do not hold the information that you have requested. Please see further details below:

**I am writing to you under the Freedom of Information Act 2000 to request the following information for NHS Lincolnshire Integrated Care Board:**

- 1. Do you currently have a contractual agreement in place for supply of services from S12 Solutions Limited based at 5 Kelso Place, Bath BA1 3AU?**
- 2. If yes, when is that agreement due to end?**
- 3. Could you please provide a copy of the service/product specification given to all bidders for when this contract was last advertised?**
- 4. Is there an extension clause in the contract and, if so, the duration of the extension?**
- 5. Has a decision been made yet on whether the contract are being either extended or renewed?**
- 6. Who is the senior officer (outside of procurement) responsible for this contract?**
- 7. What is the total value of the contract?**
